| <b>Heads Up</b>     | <b>On April 24, Western Economic Diversification Canada announced a short-term Drywall Support Program for Western and Northern Canadian drywall contractors, builders and homeowners in the Regional Municipality of Wood Buffalo.</b>   |
| <b>Details</b>      | <p>On February 27, 2017 the Government of Canada announced that anti-dumping duties that were imposed on drywall imported from the United States would be reduced and roughly \$12 million of the duties collected would support a program to distribute funding back to those affected by the higher costs.</p> <p>The Drywall Support Program will provide a one-time payment to offer partial relief to contractors and builders who faced unexpected losses due to the duties imposed on imported drywall from the United States between Sept. 6, 2016 and February 24, 2017.</p> <p>The program is also aimed to assist the middle class families in the Regional Municipality of Wood Buffalo rebuild following the 2016 wildfires.</p> |
| <b>How it works</b> | <p>The program is set to give nearly \$12 million of anti-dumping duties back to eligible applicants. Eligible applications include contractors, builders and homeowners in the Regional Municipality of Wood Buffalo.</p> <p>Applications are being accepted between May 1 and 31, 2017.</p>   |
